Terms and Conditions of Membership

1. I acknowledge that, as with any sport, playing Teeball, Softball and Baseball involves certain risks of accident and/or injury. Whilst Kalamunda Rangers Inc. will take all reasonable care to ensure the safety of its players, it, or its Committee, cannot be held responsible for the consequences, however serious, of events that are beyond its control.
2. I understand that the 'player' shirts remain the property of Kalamunda Rangers Inc. and I will take responsibility for the care of the shirt and will return it in good condition at the end of this season. If the shirt is damaged or not returned at the end of the season I will be liable for the replacement cost of the shirt (teeball replacement cost is \$50, all other shirts cost \$125 each).
3. Kalamunda Rangers Inc. is a volunteer organisation which requires player and family involvement. I understand that, for everyone to obtain maximum benefit and enjoyment from the game and the facilities provided by the Club, membership assistance is required. I am aware that members will be required to assist in a variety of roles over the season which may include, but not limited to, canteen duty, ground preparation, fundraising, scoring, coaching, umpiring and training.
4. I agree to abide by all the game Rules and Local Rules during my involvement in these games.
5. I agree to abide by the Club Rules and By-laws of Kalamunda Rangers Inc. and its affiliated bodies, including TBAWA, SWA, SEMSA, CSA, LLWA and BWA and undertake that my child will also abide by these Rules and Bylaws. I acknowledge that any breach of these Rules and By-laws may result in penalties being imposed. If I have a child playing with Kalamunda Rangers Inc., I am aware any penalties which may be imposed due to my breach of the Rules and By-laws can and will affect my child.
6. I am aware that player/team placement will be undertaken in accordance with the club By-laws. Players may request team placement; however, requests cannot be guaranteed.
7. I understand that I/my child will be disqualified from playing any games with Kalamunda Rangers Inc. or from receiving clearance to play at another club if I am financially indebted to the Kalamunda Rangers Inc. All fees are to be paid, in full, before the first game of the season to ensure player insurance is activated. I am aware that a non-refundable deposit of \$25 plus any pro rata season costs will be retained by the club should I withdraw prior to the end of the season. I am aware that refunds will only be issued by Kalamunda Rangers Inc. following written requests for such refund.
8. I am aware that Kalamunda Rangers Inc. complies with all legal requirements, including but not limited to the Privacy Amendment (Private Sector) Act 2000, Associations Incorporations Act 1987 and Liquor Control Act 1988, as well as our child protection requirements.
I am aware that my personal information will be held and used in compliance with these laws and to facilitate the management of the Club. I consent to the release of this information to the Team Coach appointed by Kalamunda Rangers Inc, as well as to our affiliated bodies (TBAWA, SWA, SEMSA, LLWA and BWA) as required.
